
Home prices at a new peak in January

The Teranet-National Bank HPI rose 0.3% in January, reaching an all-time high. The new record coincides with a historically high volume of home sales in most regions of Canada, coupled with limited supply. The seasonally adjusted unsmoothed Composite HPI has surged 7.8% since July (left chart). However, the uptrend of home prices does not encompass all categories of dwellings. In Toronto, the rise in sales volume was concentrated in single-family dwellings outside the downtown area, and did not take in condos. In the Greater Montreal market, a very large rise in condo listings on Montreal Island contrasts sharply with the peripheral areas of that market. In the Greater Vancouver and Victoria markets, as in Toronto and Montreal, price increases for single-family homes have significantly outpaced those for condos (right chart). Apart from a shift in preference induced by the pandemic, there is reason to believe the condo segment is affected by low immigration inflows and a persistently high unemployment rate among young workers.

Seasonally adjusted Teranet-National Bank unsmoothed HPI




HIGHLIGHTS:

- The Teranet-National Bank Composite National House Price Index[™] rose 0.3% in January.
- Seven of the 11 markets in the composite index were up on the month: Hamilton (2.0%), Montreal (1.0%), Victoria (0.6%), Halifax (0.4%), Vancouver (0.4%), Quebec City (0.3%) and Ottawa-Gatineau (0.1%). Down from the previous month were Toronto (-0.1%), Calgary (-0.2%), Edmonton (-0.4%) and Winnipeg (-0.4%).
- From January 2020 to January 2021, the Composite Index advanced 9.6%, led by Ottawa-Gatineau (19.6%), Halifax (16.9%), Hamilton (16.5%), Montreal (15.8%) and Toronto (10.0%). Lagging the countrywide average were Victoria (9.1%), Vancouver (7.3%), Quebec City (6.3%), Winnipeg (6.0%) and Edmonton (0.8%). Calgary was down 0.5% from a year earlier.




NOTE ON METHODOLOGY:

The Teranet-National Bank House Price Index is based on the repeat sales methodology. The index is built from the price increase observed between two sales of the same property.

The indexes of the 11 metropolitan markets comprising the Teranet-National Bank Composite House Price Index[™] are smoothed. Each month, the (unsmoothed) indexes are estimated for each of the last three months. The average monthly growth rate of these indexes becomes the growth rate of the smoothed index for the last month. This procedure allows evening-out month-to-month fluctuations.


